- a. The Quality Measures Development Task Force distributed a Quality Improvement and Measures Survey in April. Part of the survey asked questions on how often members use our guidelines. You can see information on this survey (Here).
- b. Overall, we received very positive comments on the guidelines portion of the survey.
- c. To understand the academic use of our guidelines better, Doug will begin to keep track of the number of citations for each of the Procedure Standards.
- 5. Proposed Procedure Standards to Retire/Discussion of Date Stamp, David Brandon, MD, Kevin Donohoe, MD
 - a. The Committee unanimously voice voted to retire the recommended Procedure Standards. The Procedure Standards ready for retirement are below.
- 6. Future of AUC and Procedure Standards, Bonnie Clarke, Sr. Director Evidence and Quality
 - a. Addition of Clinical Indications to Procedure Standards
 - SNMMI may add clinical indications to our guidelines. Doug and Julia will review other documents, created by different societies, and bring recommendations for the committee to review.
 - ii. Dr. Donohoe feels that it is still important to have separate AUC and guideline documents. He suggests continuing to create Procedure Standards and AUCs in tandem.
 - iii. We will wait for the CMS update on AUCs. The proposed rule is expected in July 2023.
 - iv. Julia mentioned that SNMMI should align future documents with procedures that are receiving larger amounts of denial claims. Members of the Committee agreed.
 - b. Discussion on Technique Used for Grading Literature
 - We will work with EANM to create a uniformed technique for grading citations in Systematic Reviews.
 - ii. If we begin to grade clinical indications in Procedure Standards, we expect to use the same strength of evidence grading system (e.g., GRADE), used in AUCs.
- 7. Discuss New Topics for AUC Development, All
 - a. Dr. Hope recommended and the group agreed on Cardiac PET with Flurpiradaz.
 - b. Dr. Donohoe recommended and the group agreed on Brain Imaging with FDG-PET. This would pair with the current FDG-PET Brain Imaging v2 Procedure Standard currently being updated.
- **8.** Discuss new Topics for Procedure Standards, All
 - a. The committee felt that the recommendations below were good starting points for our next Procedure Standards.
 - We expect to also focus on new and updated pediatric Procedure Standards in the future. The Pediatric
 Imaging Council is currently reviewing the current documents and providing their suggestions.
- 9. Document Discrepancy Discussion, Kevin Donohoe, MD, David Brandon, MD



- a. There are some discrepancies in our Gastric Emptying Guidelines. Dr. Donohoe and Dr. Brandon both highlighted that this was because the two documents were written during different times. There have been updates in this topic area.
- b. Dr. Donohoe will work with authors to update the documents to bring them into agreement, and this should serve as a reminder that we do not need to wait to update a document once new literature has been published.
